



## **COMPANIES LICENSED TO ENGAGE IN PROVISION OF SOLAR ENERGY SERVICES AND PRODUCTS**

The Energy Regulation Board (ERB) is a statutory agency established to regulate the energy sector in Zambia. Regulatory activities focus on electricity, fossil fuels and other forms of energy such as renewable energy.

Among other functions, the ERB issues licences, monitors utility performance and compliance to set standards and investigates consumer energy complaints.

The ERB would like to advise members of the public to take note of companies that are duly licensed as service providers in the solar sector. This is in the interest of ensuring that consumers are provided with quality solar energy products and services in line with ERB standards and regulations and hence get value for money.

Further, licensed companies have been assessed by the ERB for technical competence and also advise consumers on suitable solar equipment that will meet their energy needs.

Consumers also have recourse through the ERB in the event of a dispute when dealing with a licensed company.
