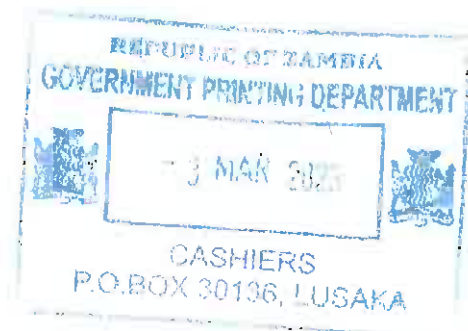
The Energy Regulation Act No. 12 of 2019
